 - Financial management
 - Property management
 - Volunteer recruitment and retention

Supplemental material:

- Applicants may submit no more than five pages of supplemental material (i.e. copies of event programs, event planning documents, social media screenshots, photographs from events, newsletters, etc.).
- Supplemental materials must be submitted as a PDF. No hard copy supplemental materials are accepted.

Affiliated House Corporation/Collegiate Chapter Relations Excellence

This award recognizes affiliated house corporations (AHC) and collegiate chapters that, through a successful joint effort, have strong communications, rapport, understanding and cooperation toward a shared purpose or goal that may include, but not limited to, an event, activity, facility management or shared governance during the biennium.

Eligibility criteria:

- Chapter was in good standing for 2024 and 2025.
- Activities must have occurred in 2024 and/or 2025.

Award submission:

- Chapter name
- Statement (not to exceed 1,000 words) describing:
 - The shared purpose, goal or program that the AHC and chapter engaged in
 - The outcome of the cooperative efforts
 - The ways in which working together strengthened the relationship between the AHC and the collegiate chapter

Supplemental material:

- Applicants may submit no more than three pages of supplemental material (i.e. planning documents, attendance records, photographs, etc.).
- Supplemental materials must be submitted as a PDF. No hard copy supplemental materials are accepted.

Facility Improvement Excellence Award

This award recognizes an affiliated house corporation (AHC) that has made outstanding improvement(s) to the chapter facility through renovation, facility enhancement or offering new and innovative amenities and services to members during the biennium.

Eligibility criteria:

- Improvement must have occurred in 2024 and/or 2025.

Award submission:

- Chapter name
- Statement (not to exceed 1,000 words) describing:
 - A description of the improvement
 - How the AHC planned for the improvement
 - How the AHC included input from collegiate chapter members in improvement
 - The way(s) in which the improvement has enhance the facility and collegiate chapter member experience

Supplemental material:

- Applicants may submit no more than three pages of supplemental material (i.e. planning documents, survey information, photographs of improvements, etc.).
- Supplemental materials must be submitted as a PDF. No hard copy supplemental materials are accepted.
