

2022 INTERNATIONAL COUNCIL AND NOMINATING COMMITTEE APPLICATION INSTRUCTIONS

Thank you for your interest in elected service for Gamma Phi Beta in the 2022-24 biennium.

Serving on the International Council (IC) or Nominating Committee (NC) is a significant opportunity to impact the organization. All alumnae members who are in good standing and committed to executing the duties of the role are eligible and encouraged to apply.

Gamma Phi Beta is dedicated to diversity, belonging, equity and inclusion and seeks for this commitment to be reflected in the application process for elected service and in the resulting leadership teams.

The election process for IC and NC members will include a written application, virtual interview(s), slating by the 2020-22 NC and voting by the 2022 Convention delegation. After review of all written applications, applicants moving forward in the election process will receive an invitation to conduct a virtual interview. The most up-to-date application timeline and information can be found at GammaphiBeta.org/NominatingCommittee.

The written application is comprised of:

1. Biographic information (personal, educational/professional, community, Gamma Phi Beta).
2. A reflective exercise utilizing the [member competencies](#).
3. An inventory of experience both in and outside of Gamma Phi Beta.
4. A series of open-ended questions related to experience, diversity and inclusion, skills and strategic thinking.

In addition to the written applications, the NC will review applicant comment forms that can be submitted by anyone (members and non-members of Gamma Phi Beta).

Applicants may solicit no more than three (3) individuals to complete comment forms on their behalf and will be asked to share the names of these references with the NC.

Please note that formal letters of recommendation will not be required or accepted.

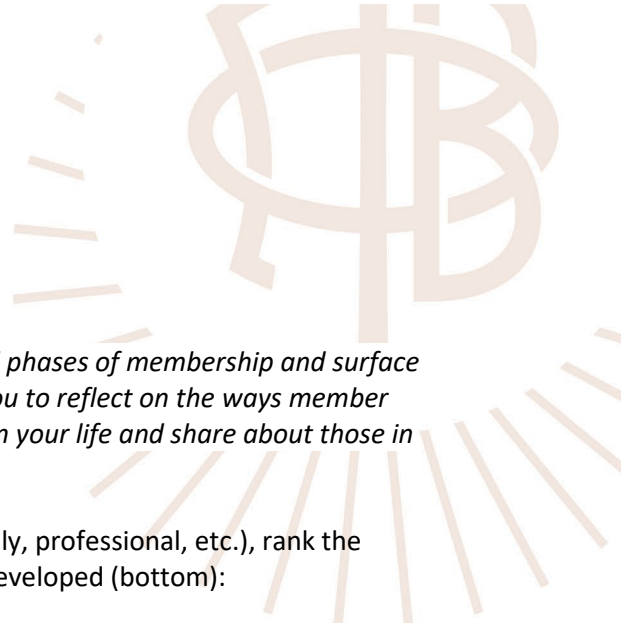



Application Questions - Essay Format

- Gamma Phi Beta’s member competencies can be demonstrated in all areas of life, and the Sorority benefits from the breadth of life experience contributed by members who serve at the elected level.

Choose two of the following three realms and expand upon a position, situation or role about which you can:

- Demonstrate strength in a member competency (including any related accomplishments) and



(b) Identify an opportunity for growth in a member competency *and* what you are doing, or would commit to doing, to grow in this area.

- Personal Experience
 - Gamma Phi Beta
 - Professional/Volunteer (non-Gamma Phi Beta)
2. At some point, you may disagree with the team when a decision is being made. Share an example of when you experienced this while in a leadership role. Your answer should describe how you shared your perspective in the decision-making process, how you responded after the decision was made and how you moved forward as a member of the team.
 3. Members of IC bear a responsibility for the financial health of the Sorority. What experience or understanding do you have of financial oversight at the board level, and what skills would you bring in financial oversight?
 4. Some members of IC will lead teams addressing different needs of the Sorority (such as the Audit and Finance Committee or Governance and Personnel Committee). Describe your experience managing a team, including information about the length of time you served in the role, depth/breadth of the project and what you learned about yourself and others through this experience.
 5. Select one of the following topic areas, identify a significant/pervasive challenge for Gamma Phi Beta in this area, describe why you think this is a challenge for the Sorority and propose one recommendation for Gamma Phi Beta (and/or connected organizations) to move in a positive direction following the recognition of the situation:
 - Financial
 - Higher education/Greek life landscape
 - Public relations
 6. The strategic plan sets the direction for the organization. If you were invited to give your opinion with the current IC on the strategic plan as it exists today, what would you share? What strategic priorities would you expect or hope the organization would consider and why?
 7. Gamma Phi Beta is committed to addressing systemic inequality by creating a more just and loving sisterhood through our belonging, equity, diversity and inclusion (BEDI) framework. How have you personally contributed to enhancing inclusion and belonging for marginalized groups? If elected to a leadership role, how would you help ensure that all members feel welcome and equally valued at all stages of membership?
 8. Accessibility, diversity and inclusion are just some of the barriers current and potential members



of all ages may experience. Identify one barrier to the full membership experience and propose ways that you, in an elected position, could help dismantle it.

9. Each member of Gamma Phi Beta has a variety of social and professional identities. How would your identities and experiences enhance the vibrancy and inclusivity of our organization and contribute to creating the leadership team you'd like the Sorority to have?
